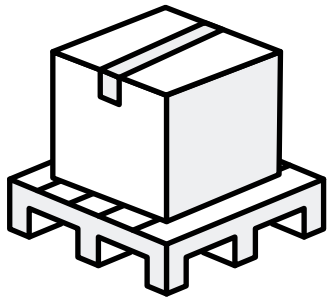

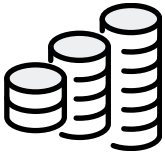
Final holders with comprehensive management agreement
